TOWNSHIP OF LOPATCONG COUNCIL MEETING 7:00 pm

December 28, 2016

The Council Meeting of the Lopatcong Township Council was called to order by Mayor McKay. The meeting was held in the Municipal Building located at 232 S. Third St., Phillipsburg, New Jersey 08865.

Mayor McKay stated "adequate notice of this meeting has been provided indicating the time and place of the meeting in accordance with Chapter 231 of the Public Laws of 1975 by advertising a Notice in The Star Gazette and The Express-Times and by posting a copy on the bulletin board in the Municipal Building."

Prayer followed by Oath of Allegiance

Present: Councilman Belcaro, Councilwoman Reitemeyer, Councilwoman McCabe, Council President Pryor, Mayor McKay. Also present Attorney Campbell and Engineer Sterbenz.

Resolution No. 16-165 - was passed to hold an Executive Session. Attorney Campbell stated Council was in Executive Session for 1 hour. Topics of discussion were one through five.

Proclamation: Chief of Police Jason Garcia presented Police Records Clerk Shirley J. Emery with a Proclamation on her retirement.

<u>Public Comment:</u> Motion for public comments on agenda items only. All in favor. No comments from the public.

John Betz – Agreed that the football field should be named after Douglas Steinhardt. Agreed that Council should approve the aerial spraying for the gypsy moths.

Motion to close public comment by Councilwoman Reitemeyer, seconded by Councilwoman McCabe. All in favor.

RESOLUTION OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN, STATE OF NEW JERSEY NAMING OF THE LOPATCONG PARK FOOTBALL FIELD, "STEINHARDT FIELD" IN HONOR OF DOUGLAS J. STEINHARDT.

WHEREAS, the Lopatcong Athletic Association has made a request of the Township to name the Lopatcong Park football field "Steinhardt Field" in recognition of the numerous contributions to the Township and the Township's Athletic Association by Douglas J. Steinhardt; and

WHEREAS, the Township joins the Athletic Association in recognizing that to have a successful youth sports organization it must rely on the contributions of its many volunteers and sponsors who generously give of their time and money; and

WHEREAS, the Lopatcong Athletic Association has suggested that there is one person whose contributions to Lopatcong Athletics are so remarkable that he deserves special recognition; and

WHEREAS, at its December 7, 2016 meeting, the Township Council reviewed the letter submitted by Lopatcong Athletic Association President Kenney Lutz listing many of the contributions made by Township resident Douglas J. Steinhardt; and

WHEREAS, the Township Council has reviewed the Resolution of the Lopatcong Athletic Association dated December 13, 2016 which formally requests the naming of the football field; and

WHEREAS, attached hereto as Exhibit A is a copy of the Lopatcong Athletic Association Resolution dated December 13, 2106 which details some of the most significant contributions of Mr. Steinhardt; and

WHEREAS, the Township Council agrees that Mr. Steinhardt's dedication to the Township of Lopatcong and its youth sports association deserves special recognition; and

WHEREAS, the Township Council agrees that naming the football field in the Township park is a fitting tribute to Mr. Steinhardt; and

WHEREAS, the Township Council wishes to ensure the that cost of the dedication sign is paid for by donations and not funded by tax dollars; and

WHEREAS, the Township Council shall have the final approval for the design, size, and location of the sign; and

WHEREAS, the Township shall designate the Township Recreation Committee as the liaison between the Township and the Athletic Association for issues concerning the sign and its dedication.

NOW THEREFORE BE IT RESOLVED that the Township of Lopatcong, County of Warren, State of New Jersey hereby names the football field in the Lopatcong Park "Steinhardt Field" in honor of Douglas J. Steinhardt and his contributions to the Township of Lopatcong and the Lopatcong Athletic Association.

BE IT FURTHER RESOLVED that the Lopatcong Athletic Association shall:

- 1. Be responsible for soliciting private donations for the cost of the sign memorializing the dedication so that no tax dollars are used to purchase the sign.
- 2. Obtain approval from the Township Council for the design, size, and location of the sign.
- 3. Work with the Township Recreation Committee regarding the erection of the sign and any ceremony for its dedication.
